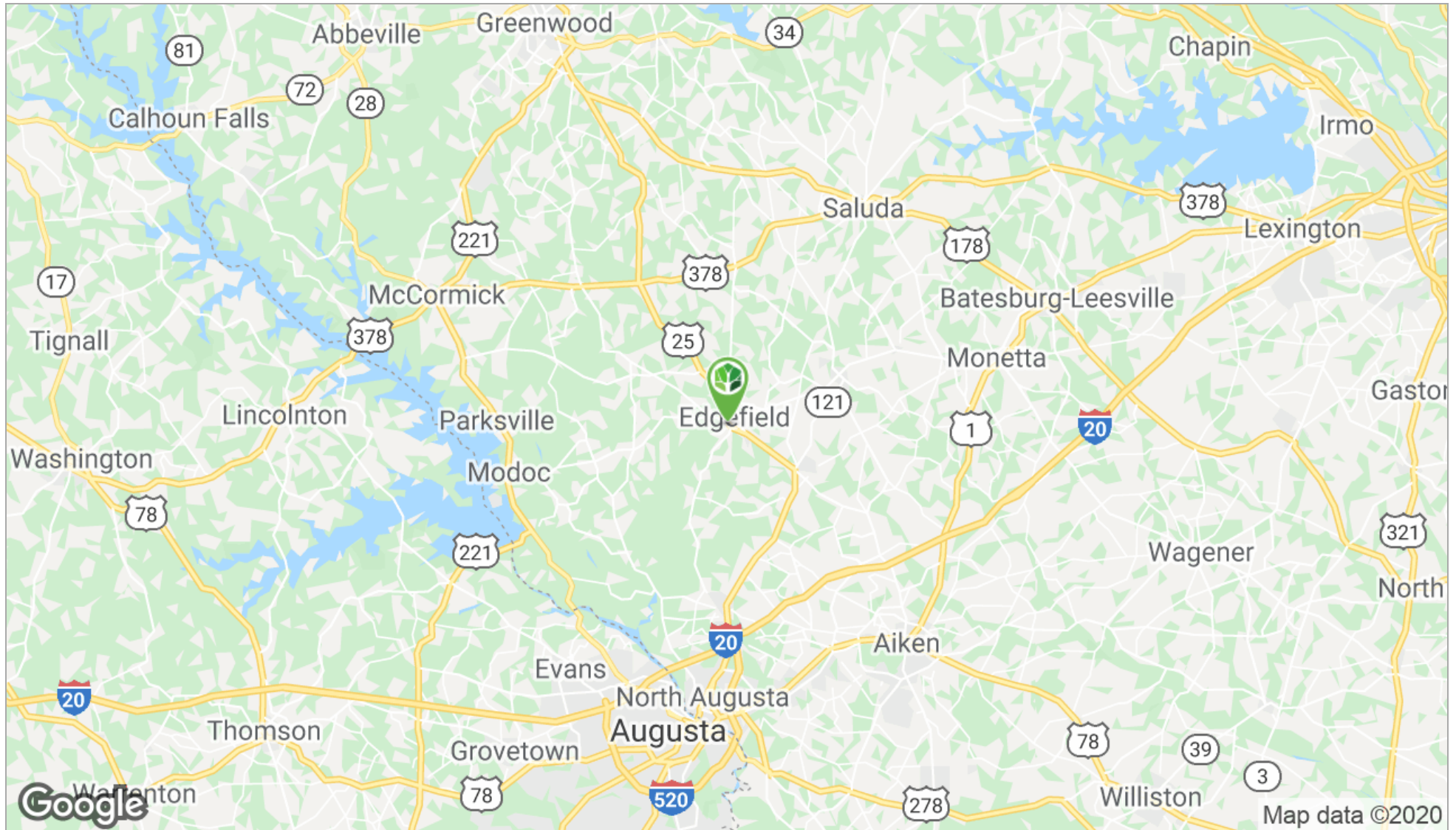

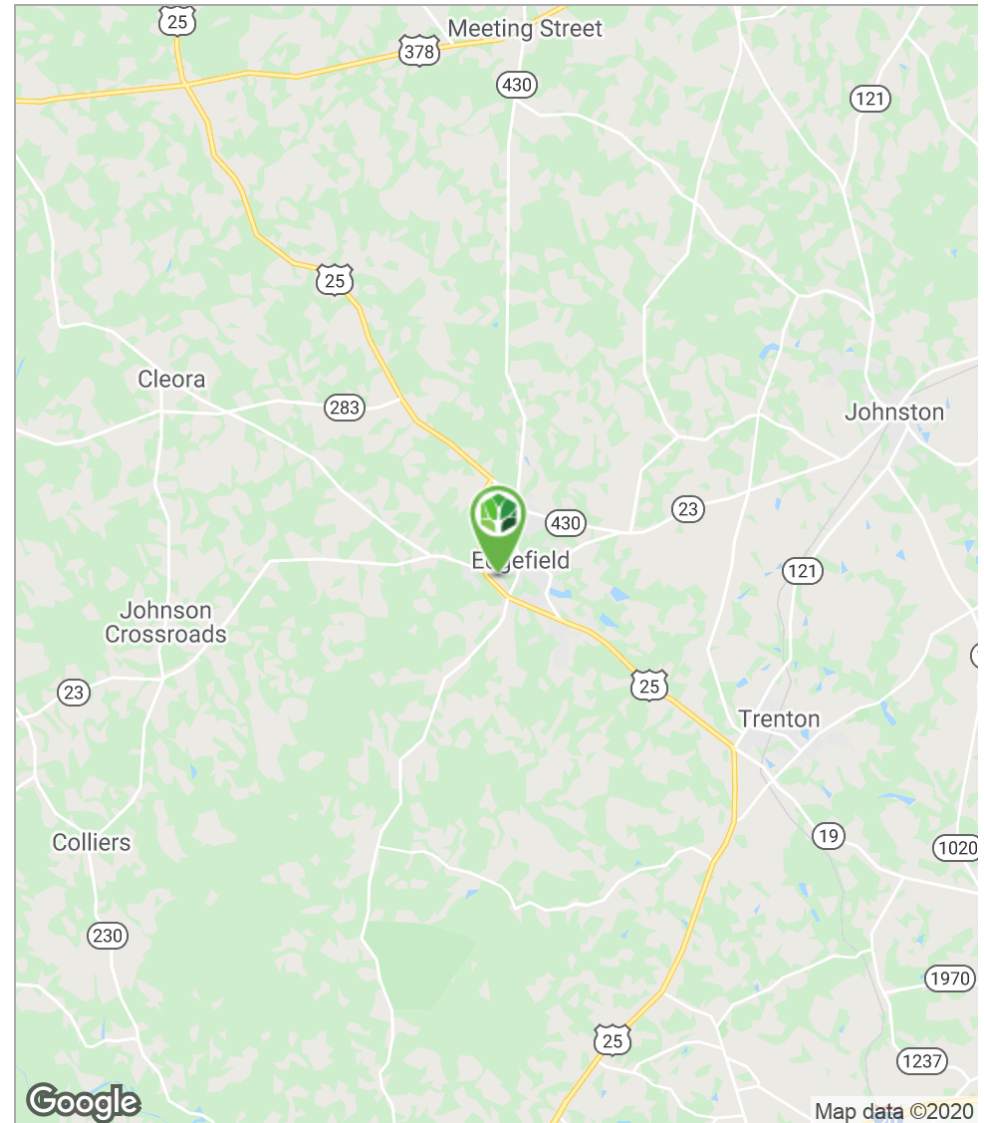
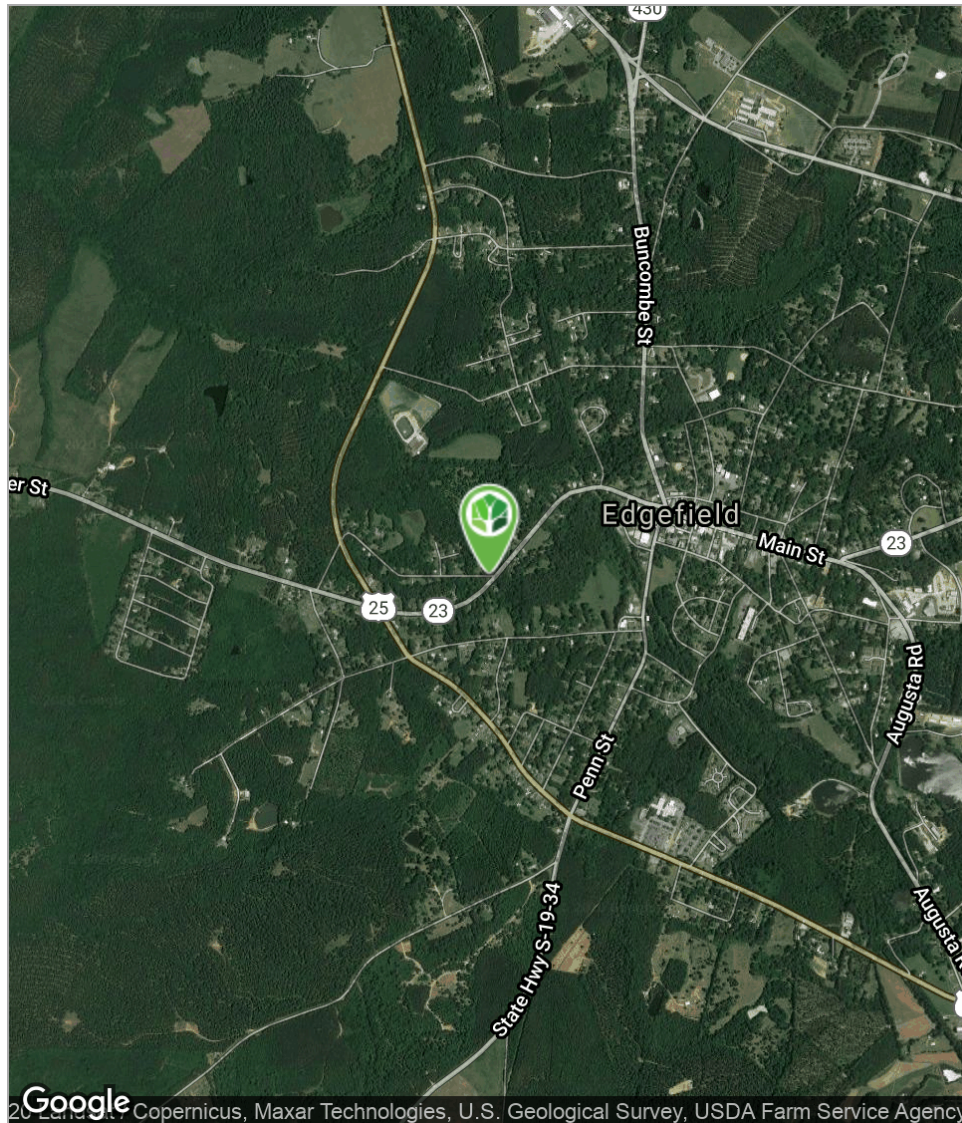
LOCATION INFORMATION | REGIONAL MAP

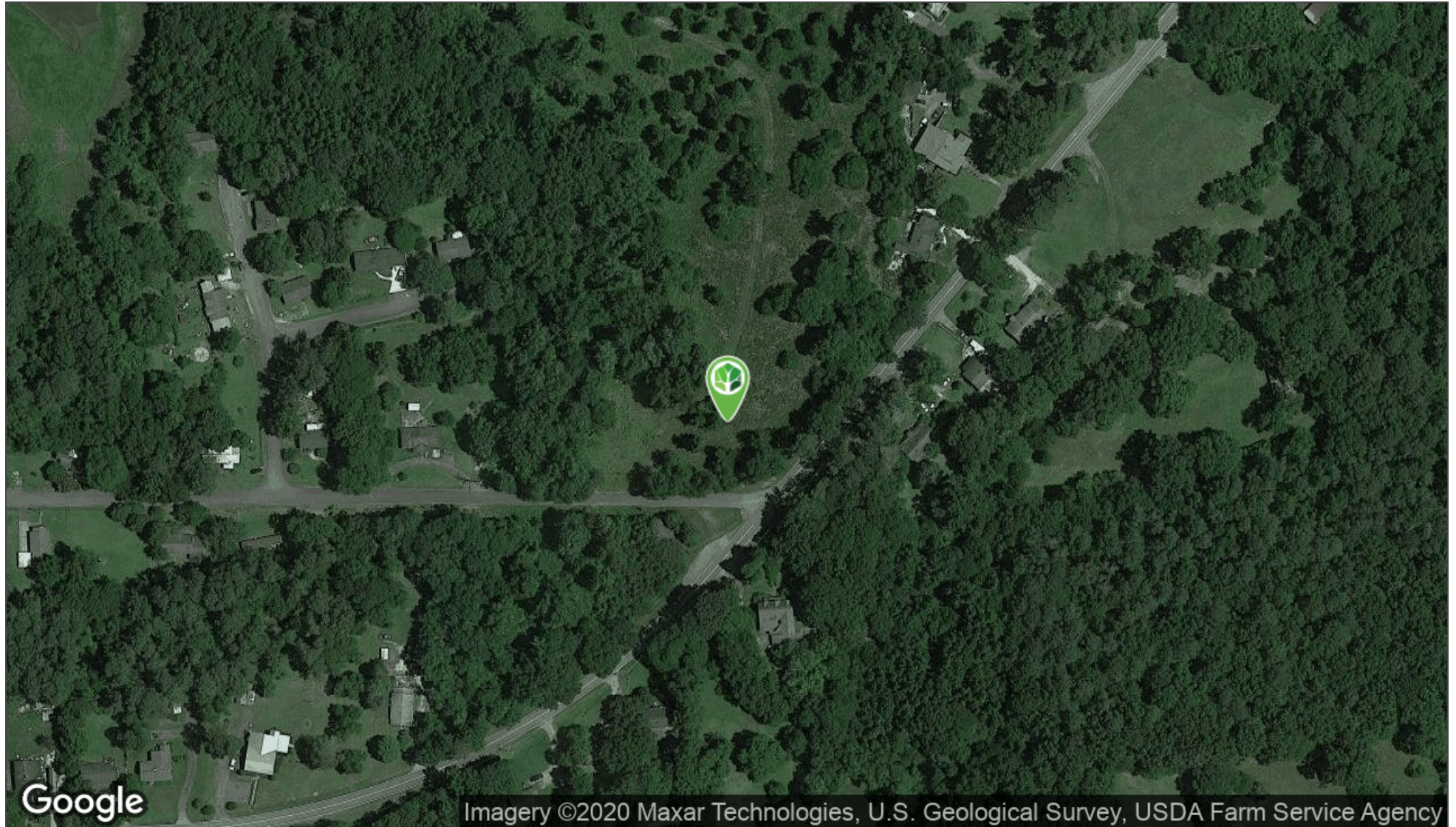
LOCATION INFORMATION | LOCATION MAPS

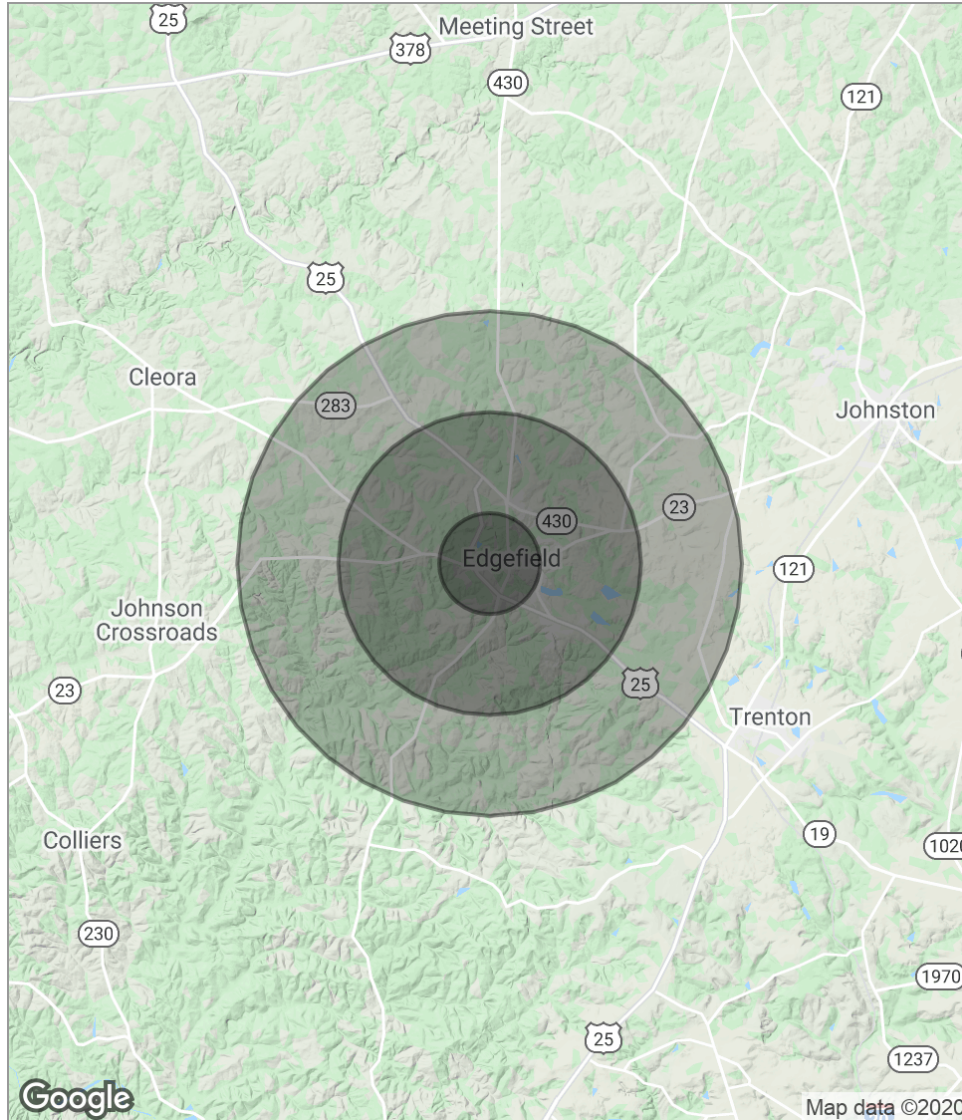
