PROPERTY OVERVIEW

Hidden away on a peaceful tree-lined street just west of downtown Bradenton sits a beautiful historic home where you can live and work! In its current configuration this property is divided into two distinct spaces; a 2552 sf residential home, and a 1629 sf commercial space.

The residential portion is a 3 bedroom/2 bath home that features hardwood floors throughout most of the living area.

The commercial space features a full bathroom, 2 half baths, storage room/office, and a bonus space that can be used as a break room and/or more storage. Although this space has been used as a pre-school the wide-open floor plan lends itself to many different uses.

Outside you will find a concrete parking lot in the front with spaces for 5 cars, extra parking behind the building with space for 3-5 cars, and a large fenced yard (currently a playground) with mature trees and landscaping offering all of the privacy you need.
