#### **MCCOMB**

McComb, the county seat of Pike County, was incorporated in 1872. The city was founded after Henry Simpson McComb of the New Orleans, Jackson and Great Northern Railroad, decided to move the railroad's maintenance shops away from New Orleans to avoid city saloons. McComb is home to Southwest Mississippi Community College and McComb High School, one of the 100 National Model Schools.

With the town's history based on the railroad system, visitors come from around the state to visit the McComb Railroad Museum. Vistitors step through the doors designed to resemble the Panama Limited train that serviced for decades through the cities from New Orleans to Chicago.

McComb contains some of the most beautiful parks in Mississippi, one being known as the Percy Quin State Park, known for its boating, fishing, campsites and 4-mile nature trail. Percy Quin State Park is approximately 7 miles of beautiful land and is located around Lake Tangipahoa.
