Thence S.89°20'19.3"E., a distance of 395.46 feet to a point on a circular curve to the right, concave westerly, the radius is 941.7 feet;

Thence southeasterly along said curve through an angle of 8°31'25" a distance of 140.09 feet, the chord of said curve bears S.10°07'43.1"E., a distance of 139.96 feet, to the point of ending of said curve;

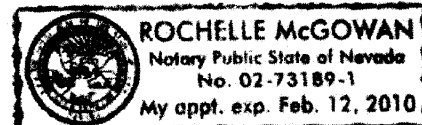
