Currently, 60.9% of the 51,509 housing units in the area are owner occupied; 35.7%, renter occupied; and 3.4% are vacant. Currently, in the U.S., 56.0% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.2% are vacant. In 2010, there were 45,552 housing units in the area - 64.1% owner occupied, 31.6% renter occupied, and 4.3% vacant. The annual rate of change in housing units since 2010 is 5.61%. Median home value in the area is \$179,938, compared to a median home value of \$218,492 for the U.S. In five years, median value is projected to change by 2.08% annually to \$199,427.
