Currently, 48.5% of the 131,724 housing units in the area are owner occupied; 43.6%, renter occupied; and 7.9% are vacant. Currently, in the U.S., 55.4% of the housing units in the area are owner occupied; 32.9% are renter occupied; and 11.7% are vacant. In 2010, there were 126,196 housing units in the area - 51.9% owner occupied, 39.9% renter occupied, and 8.1% vacant. The annual rate of change in housing units since 2010 is 1.92%. Median home value in the area is \$140,591, compared to a median home value of \$198,891 for the U.S. In five years, median value is projected to change by 4.15% annually to \$172,250.
